

Contract Agreement

THIS AGREEMENT made the 17th day of January 2022, between **Kathmandu-Terai/Madesh Fast Track (Expressway) Road Project, Nepali Army, Ministry of Defence, Government of Nepal**, (hereinafter “the Employer”), of the one part, and **M/S KUMAR-ROSHAN-SICHUAN JV, Chandol, Kathmadu-4** (hereinafter “the Contractor”), of the other part:

WHEREAS the Employer desires that the Works known as **Construction of Double Lane Dual Carriageway Standard Expressway Road, Bridge and Allied Works, Ch: 49 +800 to Ch: 57+400 (Contract I.D.: KTFT/ICB/WORKS/R&B/078/079/3)** should be executed by the Contractor, and has accepted a Bid by the Contractor for the execution and completion of these Works and the remedying of any defects therein,

The Employer and the Contractor agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Contract documents referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement:

- a) Addenda to the Contract Agreement (if any);
- b) the Letter of Acceptance/Award
- c) Letter of Technical and Price Bid
- d) the Particular Conditions Part A – Contract Data;
- e) the Particular Conditions Part B - Special Provisions
- f) these General Conditions (GCC);
- g) the Employer’s Requirements including the Specifications;
- h) the Drawings;
- i) Schedules;
- j) the JV Undertaking (If the Contractor is in JV);
- k) the Minutes of the Contract Negotiation (if any);
- l) other documents forming part of the Contract

3. In consideration of the payments to be made by the Employer to the Contractor as indicated in this Agreement, the Contractor hereby covenants with the Employer to design, execute and complete the Works and to remedy defects therein in conformity in all respects with the provisions of the Contract.
